

## REGISTRATION OF VEHICLES FROM FOREIGN COUNTRIES




### DOCUMENTS TO BE SUBMITTED ACCORDING TO THE DIFFERENT SCENARIOS OUTLINED BELOW :

#### **Vehicles with European certificate of conformity or certificate of full conformity** (*Excluding France*)


##### *New vehicles*

-  Registration application
-  Bill of sale or purchase invoice
-  European certificate of conformity, in original, supplied by the manufacturer in France or in Europe
-  Proof that tax on the vehicle has been paid from the Department of Tax Services Monaco (Europe) or Customs certificate 846A Monaco (outside Europe)
-  Foreign provisional registration certificate (if necessary)

##### *Second-hand vehicles*

-  Registration application
-  Bill of sale or purchase invoice
-  Foreign registration certificate

**(See overleaf for specific instructions relating to Germany, Italy and Switzerland)**


-  European certificate of conformity (copy) supplied by the manufacturer in France or in Europe


**Or**

Certificate of full conformity supplied by the manufacturer or the representative of the manufacturer in France

**Or**

Certificate of the french Federation of vintage vehicles (if the vehicle is over 30 years old )





-  Proof that tax on the vehicle has been paid from the Department of Tax Services Monaco (Europe) or Customs certificate 846A Monaco (outside Europe)

-  For vehicles over 4 years old, a technical inspection certificate issued in Monaco. The validity of the certificate is 6 months.

#### **Véhicules without European certificate of conformity**

##### ***Pre-study file (only copies)***

*To be given to Service des Titres de Circulation*

-  Registration application
-  Bill of sale or purchase invoice
-  Foreign registration certificate (if second-hand vehicle)
-  Certificate of partial conformity, with non-conformity points details, supplied by the manufacturer in France or in Europe

**Or** Certificate of non-conformity, with non-conformity points details, supplied by the manufacturer in France or in Europe

##### ***Study of the file***

After examination of your file, a letter will be sent to you. The procedure to follow will be given to you and if you can apply for an individual approval for your vehicle

##### **Specific cases :**

Application for individual approval for your vehicle to be given directly to the office for vehicles below with non-conformity from abroad (excluding France) :

- Véhicules over 25 years old,
- Commercial vehicles,
- Cycles, motorcycles, tricycles, quad



## SPECIFIC CASES



### Vehicles from Italy

- « Libretto » Registration certificate (in original)
- Certificato di proprietà or « foglio complementare » (in original)  
Or Certificato di proprietà digitale – ACI + copy of the certificato di proprietà print with the access code : <https://iservizi.aci.it/consultacdpd>

#### **OR**

- Certificate of ownership including the statement « cessazione di circolazione » (registered by the Italian authorities (in original)
- Photocopy of the « libretto » Registration certificate

### Vehicles from Germany

- « Fahrzeugschein » Registration certificate (in original)
- « Fahrzeugbrief » Certificate of ownership (in original)

#### **OR**

- « Teil I » (in original)
- « Teil II » (in original)

#### **N.B. :**

The « Fahrzeugbrief », the « Fahrzeugschein » the « TEIL I » or the « TEIL II » must include a note of the removal of the vehicle from German records.

### Vehicles from Switzerland

- Swiss registration certificate (in original)
- Swiss license plates (if not returned, they must be returned to the Swiss authorities)
